#### **Purpose:**

The following process is designed to find qualified service providers in a fair and open manner for the provision of professional or other service contract based on qualifications, merit and cost effectiveness. # PRELIMINARY DESIGN SERVICES FOR NEW WATER TREATMENT FACILITY RFP SUPPLEMENTAL INFORMATION

SUBMISSION DEADLINE: Refer to advertisement and posting by the Municipal Clerk.

POSITION DESCRIPTION: Burlington Township owns and operates a water supply, treatment and distribution system to provide the citizens of the Township and other users with potable water treatment. The water facilities consist of three (3) groundwater treatment plants and a distribution system which includes two (2) elevated storage tanks with combined storage of 3-million gallons. As one component of the water system, the Township has operated the water treatment plant located on Oxmead Road, Burlington Township, New Jersey since the early 1970's (the 'Oxmead Road Water Treatment Plant'). The Township has identified the need to undertake significant capital improvements to replace the existing Oxmead Road Water Treatment Plant with a new water treatment plant. It is anticipated that a new plant will be constructed adjacent to the existing plant, which will continue to provide service until such a time that the new plan can be placed into service.

The requested proposal for professional services for calendar year 2021 should include, but is not limited to, the cost for the preparation and delivery of a report providing specific information to the Township regarding the planning and design options for the replacement of the Oxmead Road Water Treatment Plant. Information about the existing Oxmead Road Water Treatment Plant is as follows:

The Oxmead Road Water Treatment Plant is an approximate 5.43-acre site located off Oxmead Road, in Burlington Township, Burlington County. The site is referred to as Block 133, Lot 5 on tax maps. The treatment plant was placed into operations in 1974. Raw water for the plant is sourced from four (4) wells, numbered 1A, 2, 3 and 4 in accordance with Water Allocation Permit No. 5327, latest effective 07/01/2017 and due for renewal 03/30/2027. At the plant, much of the equipment is utilized for iron and manganese removal from the well water. The plant contains six (6) filters using ion exchange technology to remove iron from the raw water. Water from the wells is pumped through the ion exchange filters before lime injection for pH adjustment and chlorine for disinfection prior to distribution. The ion exchange system was last upgraded in 1999 with new vessels. In 2003, the existing treatment plant control panel was replaced with a new upgraded control panel as part of a system-wide SCADA improvements project.

With all wells and filters in operation the plant produces 2,650 GPM (gallons per minute). The filter media requires regeneration and once a filter has treated 500,000 gallons, the sodium ions of the filter media have been used up and it is necessary to regenerate the filter media using a brine solution. During regeneration, the remaining five (5) filters do not have enough capacity to treat the flow from all four (4) wells. Therefore, one of the wells must be shut down during backwash. This, along with the diversion permit limiting the four (4) wells to 497.119 MG/Year, limits production to 2,150 GPM during periods of peak demand.

Currently, the filter media backwash is discharged to the Township wastewater collection system. The Township is primarily considering maintaining the use of ion exchange technology however desires to review all options, particularly the option of maintaining the use of ion exchange along with addressing / eliminating the ion exchange side effect of introducing sodium into the water, as there are undesirable effects on the wastewater collection piping and manhole structures. The Township desires to avoid choosing a treatment technology that will become obsolete because of new regulatory requi**Pements** it is requested that a discussion of anticipated regulatory requirements be provided. The proposal should

include a cost for an evaluation of existing total system demands for the purpose of providing recommendation of the appropriate design capacity for the new plant. Recommendation is requested regarding maintaining the existing four (4) wells as compared to the option of utilizing three (3) of the four (4) wells instead. A water quality review regarding how water from the new plant will react when mixing with water from the other two (2) plants in the distribution system should be included.

Finally, discussion of a broad project schedule that takes into consideration the remaining useful life of the existing ion exchange filters, along with a preliminary cost estimate is desired. At a minimum, discussion of a schedule and preliminary cost estimate should include the following: Pilot Study, Design, Specifications and Permitting, Advertisement, Construction, Construction Phase Engineering, and Take Existing Plant Off-line. It is anticipated that it will be required that the Oxmead Road Water Treatment Plant be out of service for some time period to allow for construction of the new plant. The proposal should include discussion regarding how to keep the existing plant operating as long as possibly during construction along with the suggested time period that the plant will need to be out of service.

The contractor and the Township of Burlington, (hereafter "owner") do hereby agree that the provisions of Title 11 of the Americans With Disabilities Act of 1990 (the "Act") (42 U.S.C. In providing any aid, benefit, or service on behalf of the owner pursuant to this contract, the contractor agrees that the performance shall be in strict compliance with the Act. In the event that the contractor, its agents, servants, employees, or subcontractors violate or are alleged to have violated the Act during the performance of this contract, the contractor shall defend the owner in any action or administrative proceeding commenced pursuant to this Act. The contractor shall indemnify, protect, and save harmless the owner, its agents, servants, and employees from and against any and all suits, claims, losses, demands, or damages, of whatever kind or nature arising out of or claimed to arise out of the alleged violation. The contractor shall, at its own expense, appear, defend, and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the owner's grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim, If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the *owner shall* expeditiously forward or have forwarded to the contractor every demand, complaint, notice, summons, pleading, or other process received by the owner or its representatives.

It is expressly agreed and understood that any approval by the owner of the services provided by the contractor pursuant to this contract will not relieve the contractor of the obligation to comply with the Act and to defend, indemnify, protect, and save harmless the owner pursuant to this paragraph.

It is further agreed and understood that the owner assumes no obligation to indemnify or save harmless the contractor, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the contractor expressly understands and agrees that the provisions of this indemnification clause shall in no way limit the contractor's obligations assumed in this Agreement, nor shall they be construed to relieve the contractor from any liability, nor preclude the owner from taking any other actions available to it under any other provisions of the Agreement or otherwise at law.
